# Rail Staff Travel Guide for holders of the RST Online Leisure Card

## Section 1: Introduction

This is a guide to the National Rail Staff Travel facilities for those people who hold the RST Online Leisure Card.

Use of travel facilities is subject at all times to the:

- Rail Staff Travel Conditions of Issue and Use [www.raildeliverygroup.com/rst/conditions-of-issue-and-use.html](http://www.raildeliverygroup.com/rst/conditions-of-issue-and-use.html)
- National Rail Conditions of Travel [www.nationalrail.co.uk/nrcot](http://www.nationalrail.co.uk/nrcot)
- Travel Restrictions (updated a minimum of twice a year) [www.raildeliverygroup.com/rst/where-can-i-go.html](http://www.raildeliverygroup.com/rst/where-can-i-go.html).

The scheme is for leisure travel on some carriers in Britain only.

- It is **not valid** for travel on the Caledonian Sleeper, Hull Trains, Grand Central, London Overground, or Docklands Light Railway.
- It is **not valid** for travel on London Underground (except when crossing London between London Terminal stations using a ticket containing the Cross-London marker)
- It is **not valid** for travel on the Elizabeth Line (except when crossing London between Liverpool Street and Paddington on a ticket containing the Cross-London marker)
- **Residential travel (i.e. using staff travel benefits for commuting to and from work) is not included.**
- **Free and discounted travel on Eurostar and other European carriers through the FIP scheme is also not included.**

## **Section 2: Types of Travel and the concession available**

The RST Online Leisure Card can only be used to purchase tickets for leisure travel.

This is classified as travelling for social/pleasure reasons. This means that it cannot be used to purchase tickets for travelling to work, school or college, etc and also cannot be used to purchase tickets to travel between work locations during the working day.

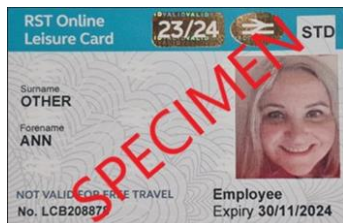
It also cannot be used to purchase tickets for any other trading or other remunerative activity.

The use of staff discounted (priv rate) tickets for leisure travel is permitted for employees, spouse/partners and child dependants.

## Section 3: Rail Staff Travel products

### RST Online Leisure Card



Leisure travel is delivered via the **RST Online Leisure Card**. The card must be kept as issued and not laminated or altered in anyway.

You can use it to purchase unlimited staff discounted (priv rate) tickets for leisure travel on all rail services in Great Britain except:

- Caledonian Sleeper
- Elizabeth Line
- Grand Central
- Hull Trains
- London Overground

All tickets must be purchased via RST Online only. Although RST Online will display fares for the above operators (as you may want to purchase full fare tickets for them) if you purchase priv-rate fares and travel on those operators that is deemed a travel irregularity.

**Staff discounted (priv rate) tickets cannot be purchased from station ticket offices or on-board trains by holders of the RST Online Leisure Card.**

Staff discounted (priv rate) tickets can only be used by the RST Online Leisure Card holder and cannot be given to anyone else to use for travel – they are not transferrable to any other person.

You must have the RST Online Leisure Card with you and available for inspection when travelling using staff-discounted (priv rate) tickets. If you cannot present the RST Online Leisure Card with any staff-discounted (priv rate) tickets, then the Train Operating Company will follow their revenue protection procedures and treat you as a passenger without a valid ticket.

If you travel without your RST Online Leisure Card and have to purchase public rate tickets, or pay a penalty fare, you cannot get this refunded.

### **Loss & Replacement of RST Online Leisure Cards**

All losses, for any reason, must be reported to RST immediately, even if you are not going to order a replacement. If you do not and someone else is found using it, you will be liable for the misuse. A replacement fee is payable if cards are lost, damaged or destroyed. The fee may be waived if loss is the result of theft, robbery or fire, subject to evidence of this being produced from the relevant police or fire service authorities.

Post losses notified later than 31 December must be paid for. There are no exceptions to this rule as this is to support fraud prevention.

Likewise if you move house and do not let RST know your new address, and are unable to collect your cards/passes you will need to pay a replacement fee before replacements can be issued.

The current replacement charge is £15.00 for each RST Online Leisure Card that needs to be replaced.

To request any replacement card or pass, you must submit one of the forms below:

- Replacements of Lost or Damaged Cards (XX35) or
- Replacement of Faulty or Stolen Cards (XX34)

## Section 4: Joining and leaving the rail industry

### Joining Network Rail

When you start employment Network Rail will notify Rail Staff Travel and provide us with your details if you have opted to receive an RST Online Leisure Card.

Once we have created your Rail Staff Travel record, you must upload a passport-style photo of you before we can issue your RST Online Leisure Card. [www.raildeliverygroup.com/rst/photo-upload.html](http://www.raildeliverygroup.com/rst/photo-upload.html)

Once we have your information and photo, we will send your RST Online Leisure Card to your home address.

You will also receive an email with your one-time pass-code so you can register for **RST Online**.

**You can only buy tickets via *RST Online* once you have received your physical card in the post as you need to have this with you when you travel.**

### Opting out of the scheme

You should only apply for an RST Online Leisure Card if you intend to use it for the duration of its validity.

If you do need to opt out due to personal circumstances then you can do this. However you will need to return all cards issued before charges cease.

Additionally you will not be able to opt in again for twelve months.

To opt out you need to:

- email [rst@raildeliverygroup.com](mailto:rst@raildeliverygroup.com) stating that you want to opt out. and
- Return all cards issued to RST. Cut each card into four, with the card number visible, and email to [rst@raildeliverygroup.com](mailto:rst@raildeliverygroup.com).

### **Resignation, retirement, redundancy or dismissal**

Your eligibility for rail staff travel facilities ceases when you leave employment with Network Rail, irrespective of the reason for leaving.

All RST Online Leisure Cards for you and all family members must be returned to Rail Staff Travel when you leave. Cut each card into four, with the card number visible, and email these to [rst@raildeliverygroup.com](mailto:rst@raildeliverygroup.com)

If you fail to do this and then join another company that offers rail staff travel, RST will not issue any new cards/passes until the RST Online Leisure cards expire or are returned.

Your access to your RST Online account will also be removed.

## **Section 5: Eligibility of family members**

### **Spouse/Partners and child dependants**

As a general rule you can apply for travel facilities for the following who must all permanently reside at the same home address as the employee:

- one spouse or partner who permanently lives with you
- resident dependant children up to the age of 18
- resident dependant children (though they may reside at another temporary address in term time if they attend college or university elsewhere) between 18 and 25 subject to annual declaration of continued eligibility
- resident dependant children aged 25+ in very limited circumstances

Children under age 5 travel for free on most National Rail services. Staff travel facilities are not normally issued until a child reaches their 5<sup>th</sup> birthday. However RST will issue national staff travel facilities once a child is over twelve months of age.

When adding children aged 18 or over to your record for the first time you will likely need to provide some additional information depending on their age and circumstances.

If they have been in education since they were 18, are still in continuous education you will have to provide proof of this.

If there are gaps in their education (other than during holidays) we will need an Employment Letter (OCA41) from HMRC as part of your application. This is because we will need confirmation that they have not earned over the weekly threshold as this would make them ineligible for the RST Online Leisure Card.

Once a child dependant is earning over the weekly limit (unless they are in full time education and earning more during the holiday time only) then they are not eligible for the RST Online Leisure Card.

It is up to the employee to decide whether spouse/partners and child dependants are issued with an RST Online Leisure card. No partner or child dependant is independently eligible for anything.

The Employee is responsible for the correct use of RST Online Leisure cards issued to spouse/partners and child dependants.

Employees can apply online at

The forms are

- *Add Spouse or Partner (XX02a)* - if for a partner you will also need the *Partner Declaration (XX03)*
- *Add Child Dependant (XX02b)*- if child is aged 18 or over you will also need the *Child Declaration (XX05)*

### Divorce or separation from a spouse/partner

In the event of divorce or legal separation, or no longer living together, any RST Online Leisure card issued for the spouse/partner must be returned.

**Once a partner is no longer eligible the employee must inform RST immediately by completing a *Dependant Card Not Required* form XX24 on the RST website.** Please attach images of the cards to the XX24 form, but if there are problems attaching them they can also be sent by e-mail to [rst@raildeliverygroup.com](mailto:rst@raildeliverygroup.com)

You cannot apply for facilities for any new spouse/partner until the passes from the first partner have either been returned or have expired by date.

## Children no longer dependant on the employee

When children are no longer dependant on the employee, either by gaining employment, leaving home or entering into a serious relationship, any RST Online Leisure cards issued to them must be returned.

**The employee must inform RST immediately by completing a *Dependant Card Not Required* form XX24 on the RST website.** Please attach images of the cards to the XX24 form, but if there are problems attaching them they can also be sent by e-mail to [rst@raildeliverygroup.com](mailto:rst@raildeliverygroup.com)

## Facilities for a couple, both employed in the rail industry (where one already receives some rail staff travel facilities)

If you already receive a Rail Staff Leisure Card or a Staff Travel Card through a partner or spouse that works in the industry it is better than you retain that one. This is because you may be eligible to a FIP card for reduced rate travel in Europe through them but you are not eligible for this through this scheme.

We recommend that you approach RST for specific guidance.

### Section 6: Travel on National Rail on services where the RST Online Leisure Card is valid.

It is **not valid** for travel on the Caledonian Sleeper, Hull Trains, Grand Central, London Overground, London Underground or Docklands Light Railway.

It is **not valid** for travel on the Elizabeth Line (except when crossing London between Liverpool Street and Paddington on a ticket containing the Cross-London marker)

#### Staff discounted (priv-rate) tickets

Staff discounted (priv-rate) tickets are not valid on TfL Underground and DLR services in London except when the ticket shows the Cross-London Indicator (+), in which case it may be used on London Underground to cross London between the relevant London Terminal stations only.

### Buying staff discounted (priv rate) tickets with the RST Online Leisure Card

The RST Online Leisure Card can only be used to buy tickets online through **RST Online** at [www.railstafftravel.com](http://www.railstafftravel.com)

You can only access the service once you have been issued with a *one-time passcode* by Rail Staff Travel which will enable you to register and create your on-line account.

Rail Staff Travel will send your *one-time passcode* by e-mail once you have been issued with your RST Online Leisure Card.

RST Online offers journey planning facilities to enable you to find staff discounted and public fares, buy tickets and make seat reservations. You can collect the tickets bought through **RST Online** at a Ticket Vending Machine at a station, or you can have e-tickets sent to your registered e-mail address.

Although you can purchase tickets for all carriers, please remember that it is not valid for travel on the Caledonian Sleeper, Hull Trains, Grand Central, London Overground, London Underground or Docklands Light Railway.

It is also **not valid** for travel on the Elizabeth Line (except when crossing London between Liverpool Street and Paddington on a ticket containing the Cross-London marker)

Therefore, you must not purchase staff discounted (priv rate) tickets for services on which staff discounted (priv rate) tickets bought with the RST Online Leisure Card are not valid.

You can purchase a Rover or Ranger with a start date of between 7 and 14 days from the date of purchase. Rovers and Rangers are printed and posted to you by 1st class post. There is no other fulfilment option available.

### Staff Travel Restrictions

The use of staff discounted (priv-rate) tickets is subject to **Staff Travel Restrictions**.

These are updated at least twice a year on the RST website at [www.raildeliverygroup.com/rst/where-can-i-go.html](http://www.raildeliverygroup.com/rst/where-can-i-go.html)

It is the responsibility of the employee and their family member to ensure they do not travel in contravention of the Staff Travel Restrictions. It is not the responsibility of RST Online to prevent the sale of tickets on trains which are subject to the Staff Travel Restrictions.

Staff and family members must ensure priority is given to fare-paying passengers. They should, whenever possible, seek to travel on lightly loaded services. When this is not possible and travel is undertaken on a crowded train, they should stand back to allow fare-paying passengers to obtain seats.

Travelling on restricted services is a Travel Irregularity which will put your facilities at risk of withdrawal.

## Class of Travel

The RST Online Leisure Card is for Standard Class staff discounted (priv-rate) tickets only.

Where a TOC offers Weekend First upgrades, RST Online Leisure Card holders with Standard Class staff discounted (priv-rate) tickets, may purchase the Weekend First upgrade (subject to availability) from staff on board the train at the public rate and travel in First Class accommodation.

A few TOCs also allow the purchase of upgrades for First Class using apps such as Seatfrog, however, not all of them allow this. If it is permitted, it will be documented in the **Staff Travel Restrictions**.

Apart from the exceptions above, you cannot pay the difference between Standard Class and First Class fares to travel in First Class accommodation.

## Seat Reservations

When purchasing a staff discounted (priv-rate) ticket it is normally possible to make a seat reservation.

Some TOCs restrict staff from making seat reservations and the rules are in the **Staff Travel Restrictions**.

### **Travel to and from the Isle of Wight**

Staff discounted (priv rate) travel is available on services wholly on Island Line (Isle of Wight) services. However, there is no staff discounted (priv rate) available for the ferry crossing between Portsmouth Harbour and Ryde Pier Head so staff discounted (priv rate) tickets for through travel to and from the mainland are not available from RST Online.

### **Unavailability of tickets**

In the event of a prolonged system outage of RST Online or any Rail Industry system which prevents all staff discounted (priv rate) online ticket purchase, Rail Staff Travel will arrange messaging for ticket office and on board staff to accept the RST Online Leisure Card on a temporary basis until the service is restored.

Rail Staff Travel is not liable for the unavailability of specific fares within RST Online.

There are no other circumstances under which you may purchase staff discounted (priv rate) tickets at stations or on board trains. Rail Staff Travel, the Train Operating Companies and other retailers are not liable if you are unable to purchase staff discounted (priv rate) tickets through RST Online and you choose to purchase full price tickets from other sources.

Where operational staff believe a ticket has been purchased from a station or on a train when RST Online was working, they will report this to RST for further investigation.

## **Sleeper Services**

### **Caledonian Sleeper**

The RST Online Leisure Card is not valid for any travel on Caledonian Sleeper services.

### **Great Western Railway sleepers**

Great Western operate the Night Riviera sleeper between London Paddington and Penzance.

Employees, spouse/partners and child dependants are eligible for staff travel on Great Western Railway Sleeper:

To travel you must purchase a staff discounted (priv-rate) ticket and pay the sleeping berth supplement.

The berth supplement is £60 for a berth in a twin cabin, or £90 for a berth in a solo cabin. The twin cabin cannot be shared with a stranger, so if two pass holders are travelling, the price is £120. There are no discounts on the berth supplements for any category of customer (Child / Railcard / PRIV etc.).<sup>1</sup>

## **Travel Irregularities**

Employees are responsible for the proper use of all rail staff travel facilities that are issued to themselves and their families. The Employee has absolute

discretion as to whether they allow their spouse/partner and child dependant(s) to enjoy these facilities.

There are penalties if any holder of an RST Online Leisure card whether employee, partner or dependant child, attempts to use it fraudulently or allows someone else to do so.

If a primary cardholder transgresses, the spouse/partner and all dependants also lose their facilities; if a spouse/partner or dependant child is at fault, then generally just that individual is subject to penalty.

Any person who is found to:

- improperly use any RST Online Leisure Card;
- improperly use any ticket purchased with the RST Online Leisure Card;
- transfer any card or ticket, or attempt to do so;

will be liable to prosecution, permanent withdrawal of rail staff travel facilities and, if an employee, possible dismissal.

**Staff discounted (priv-rate) leisure tickets purchased with a RST Online Leisure Card are not valid for business, trading, duty or residential use (commuting to work or travel to educational establishments) by either employees, partners or dependant children. Where such cases are detected they will be treated as a travel irregularity.**

## **Section 8: Other rail undertakings in Great Britain**

Travel facilities are granted to employees, spouse/ and child dependants on some other transport undertakings as indicated below.

### **Heathrow Express**

Staff discounted (priv-rate) tickets can be bought from RST Online.

Children under 16 travel free at all times on Heathrow Express, as long as they travel with a fare-paying adult. Customers travelling with children under 16 should ask Heathrow Express staff to open the ticket gate for them, to allow entry to the platform. Children who have a 5-10 or an 11-15 Zip Oyster photocard or a Young Visitor discount added to a standard retail Oyster card or to a Visitor Oyster card should not touch in or out. There is no limit to the number of accompanied children allowed to travel for free.

### **LUMO**

Staff discounted (priv-rate) tickets can be bought from RST Online.

### **West Coast Railway Company - The Jacobite**

Steam-hauled main line charter trains operate services between Fort William and Mallaig typically from April to October.

### Heritage Railways (generally not on the National Rail network)

If you want to travel on the services below, you will need to purchase your staff discounted (priv-rate) tickets direct from the operator. Please note that staff discounted (priv-rate) travel is generally not available on special event days. ## **Section 9: Travel in London**

The RST Online Leisure Card is not valid for staff discounted (priv-rate) travel on London Overground, Elizabeth Line, London Underground, Dockland Light Railway, bus and river services.

The only exception to this is except where the ticket shows the Cross-London Indicator (+), in which case it may be used on London Underground services only to cross London between the relevant London Terminal stations only and the Elizabeth Line between Liverpool Street and Paddington only.
